

Conformity assessment is a procedure in which, the issuing documents of conformity confirms that a product complies with the standard, technical and other regulations or technical specification

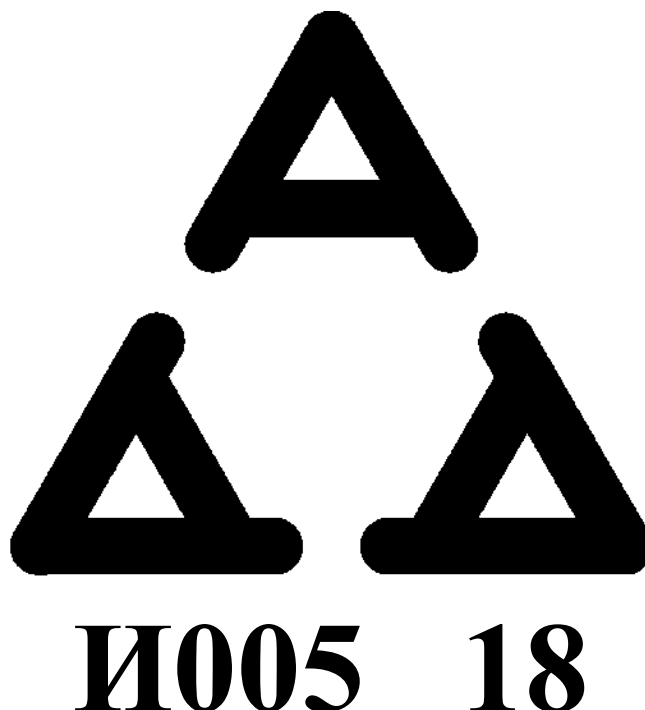
Conformity assessment of products is carried out according to:

- "Rulebook on Electromagnetic compatibility" ("Official gazette of RS", No. 25/2016),
- "Rulebook on electrical equipment designed for use within certain voltage limits" ("Official gazette of RS", No. 25/2016)
- "Rulebook on safety of machinery" ("Official gazette of RS", No. 58/2016).
- "Rulebook on radio and telecommunication terminal equipment ("Official gazette of RS", No. 11/2012)

Every product that is compliant with the above mentioned RULES must be marked with a mark of conformity against to the "Regulation on manner of conformity assessment, content of document of conformity, and shape, appearance and content of the mark of conformity" ("Off. Gazette of RS", no. 98/2009) as well as "Regulations on the Manner of affixing marks of conformity on products use of marks of conformity " (" RS Official Gazette ", No.25 / 2010) of the form

### **SERBIAN MARK OF CONFORMITY**

Serbian mark of conformity consists of three uppercase letters A connected in form of equilateral triangle (3A), the looks and content as shown:



The height of the mark is, as a rule, must be at least 5 mm.



Together with Serbian Mark of conformity need to place the identification number of the Notified or authorized conformity assessment bodies, listed in register of notified and designated conformity assessment bodies (H005) and the last two digits of the year of issuing Certificates of conformity if that body is performed, or participated in the conformity assessment..

Serbian mark of conformity on the appliance affixed by the manufacturer or his representative or importer if the manufacturer or its representative is not registered in the territory of the Republic of Serbia, in a visible place so as to be legible and indelible and clearly visible if possible on the same plate with the other marks. The same should not be placed on the parts that are removed when repairing or servicing the product.

On the appliances may be placed and other marks, symbols, labels or other markings, provided that they do not affect the visibility, legibility and / or meaning of the mark of conformity.

If a particular appliance subject and to other regulations regulating other issues, which also regulates the placing Serbian mark of conformity, placed Serbian mark of conformity indicates that this appliance complies with the requirements of these regulations.

The holder of a certificate or statement of conformity must not use document of conformity in a manner that may bring into question the reputation of "Kvalitet" a.d. or to give information regarding the compliance of the product contrary of this guide.

The holder of document of conformity is obliged to inform in writing "Kvalitet" a.d related to the eventual changes of the harmonized product. "Kvalitet " a.d. is obliged to notify the holder of document in writing, whether issued document of conformity remain in force or necessary to do additional testing / evaluation, to maintain document of conformity.

The holder of document of conformity can not be used obtained document of conformity and Serbian mark of conformity after the expiry date of document of conformity.

The "Kvalitet" a.d. will be with its solution suspend / revoke issued a document of conformity, if the conclude in any way, that the holder of document of conformity does not fulfil the conditions under which it was issued document of conformity solution.

The holder of document of conformity must for the period of suspension, or revocation of document of conformity, to prevent the circulation of products labelled with Serbian mark of conformity.

The objection or appeal the holder of documents of conformity to the solution on suspending / revoking document of conformity does not postpone the execution of a solution.
